AUTOMATE LICENSE AGREEMENT

IMPORTANT-READ CAREFULLY: This End-User License Agreement ("EULA") is a legal agreement between you (either an individual or a single entity) and Network Automation, Inc and its suppliers and resellers for the Network Automation, Inc software product identified above, which includes computer software and may include associated media, printed materials and "online" or electronic documentation ("SOFTWARE PRODUCT"). SOFTWARE PRODUCT LICENSE
